Our library media is a central resource for our foundation containing materials specially selected to meet the reading interests of our children.

Please read this permission form together with your child, sign it and return it so your child can fully utilize the library facilities. This represents an agreement between you, your child, and the foundation that you will be personally and financially responsible for any lost or damaged book.

We encourage our kids to check out library books to extend and enrich their enjoyment of reading and enable them to learn research techniques. It is, however, imperative that books be returned in good condition and on time. **All lost books must be paid for \$30 each. A fee of \$2.00 will be charged for books that are damaged and can be repaired. Members may not check out any other book until the charges are cleared from their account.**

Together we can help your child develop a love of reading and responsible habits in the care of books. Please sign below and return to the front desk as soon as possible to begin checking out your favorite titles.

This form must be signed before your child will be allowed to check out a book from the library. I give my child permission to check out books and will be responsible for any lost or damaged books.

LIABILITY WAIVER AND HOLD HARMLESS AGREEMENT

I, as parent or legal guardian of the child whose name is set forth below (each referred to as a “Participant” and collectively referred to herein as the “Participants”) and in consideration of the Participants being permitted to participate in the Activities (as defined below) conducted by The Joy culture Foundation, located at

I agree as follows:

- 1 **Activities** – Activities shall be defined as the various activities offered to Participants by The Joy culture Foundation, an indoor playground, library and program.
- 2 **Assumption of Risk** – I understand that the Activities entail the risk of severe bodily injury to the Participants. Injuries that could result may vary, but may include (a) minor injuries such as scratches, bruises and sprains; (b) major injuries such as eye injury or loss of sight, joint or back injuries and concussions; and catastrophic injuries, including paralysis and even death. I understand that, The Joy culture Foundation cannot eliminate all risks or guarantee the safety of the Participants while Participants participate in the Activities. I have made my own investigation of these risks, understand these risks, and assume them knowingly and willingly on behalf of myself and my minor Participant child. Notwithstanding these risks and other hazards that may be foreseeable but not specifically identified herein, I, for myself and any minor Participant child, and our respective heirs, personal representatives and assigns, understand, acknowledge, and expressly and voluntarily assume all risks and full responsibility for any injury arising out of or related to the Activities.
- 3 **Release, Discharge and Agreement Not To Sue** – I, for myself and any minor Participant child and our respective heirs, personal representatives and assigns, do hereby release, discharge and agree not to sue The Joy Culture Foundation or its managers, members, employees and/or other agents, for any injury to or death of any Participant arising, directly or indirectly, from participation in the Activities. This release, discharge and covenant not to sue shall relate to any and all claims or legal rights now existing or arising in the future, including claims and legal rights arising out of any negligence of The Joy Culture Foundation and/or its managers, members, employees and/or other agents and any other breach of a legal duty arising out of common law, statute, contract or otherwise.

- 4 **Indemnification And Hold Harmless** – I agree to indemnify The Joy Culture Foundation and hold The Joy Culture Foundation harmless from, without limitation, any and all claims, actions, suits, procedures, costs, expenses, damages and liabilities, including attorney’s fees and costs, incurred due to claims brought by any party as a result of or arising out of my or my minor Participant child’s involvement in the Activities and agree to reimburse The Joy culture Foundation for any such costs, expenses and fees as they are incurred.
- 5 **Parent Or Legal Guardian Certification And Consent** – I hereby certify that I am the parent or legal guardian of the minor Participant children whose name(s) appear below, and I have authority to waive rights on behalf of the minor Participant(s). I have read and I understand all of the provisions of this document and the risks of the Activities. I understand that the Activities could cause injury and even death. I acknowledge that I have read and understand the terms of this document and I am freely and voluntarily signing this document.
- 6 I hereby grant the The Joy culture Foundation permission to use myself or my children in a photograph, video, or other digital media (“photo”) in any and all of its publications, including web-based publications, without payment or other consideration

PLAYGROUND RULES

1. Play space will be closed for cleaning and sanitization in the last 10 mins of each hour.
2. Shoes are not allowed in the play area. All adults and children are required to wear socks when entering the play area (by health code).
3. No food and drinks in the play area.
4. Parents and guardians, not The Joy Culture Foundation staff, are responsible for children and must remain on site at all times.
5. Wash hands before entering the play area.
6. Take good care of toys and equipment, and put items into “Used Bins” for cleaning and sanitization after usage.
7. The Joy Culture Foundation is not responsible for lost or stolen items.
8. For safety reasons, children should enter the play space appropriate to their age.
